- **1.** Please print or type this form.
- 2. Name, address, and WRC customer number Pertaining to individual listed on the license.
- 3. Species Gray fox, red fox or coyote
- 4. Date of Capture List the date of capture, which is when species was caught in your trap
- 5. County of Capture List the county where the animal was trapped.
- 6. **Disposition of Species** Specify if species transferred, sold, dispatched, died, or other (please specify)
- 7. **Date of Disposition** List date that the live gray fox, red fox, and/or coyote was transferred, sold, dispatched, died, or other.
- 8. Transportation Permit Number List the transportation permit number that was issued to you.
- **9. Preserve Operator License Number** List the controlled fox hunting operator's license number where animal was sold/transferred to, if applicable.
- **10. Transportation Permit Number** If someone else is transferring the live fox or coyote to the preserve operator on your behalf, list their transportation permit number and/or their CFP license number, whichever is applicable (see below):
 - Individuals transporting live foxes and coyotes to or from a licensed CFP shall have a valid transportation permit.
 - Individuals transporting live foxes and coyotes on behalf of a licensed CFP shall have a valid transportation permit or a copy of the operator's current CFP license.
