

Nominations Sought for 2016 Wildlife Conservation Award

The N.C. Wildlife Resources Commission is seeking nominations through Jan. 29, 2016 for the 11th annual Thomas L. Quay Award.

The award recognizes individuals who provide leadership in the conservation of wildlife diversity in North Carolina.

Anyone interested in nominating someone for the award must submit the nomination form on the next page and a detailed essay of the nominee's contributions to wildlife conservation. The essay is limited to two pages (8 ½ x 11-inch paper, with 1-inch margins, single spaced and 12-point font). Submissions that exceed the 2-page limit will be disqualified and returned to the nominator.

In addition to this year's nominations, nominations submitted in 2014 and 2015 will be considered. Nominations submitted before 2014 will be considered upon request.

The Nongame Wildlife Advisory Committee will recommend nominees for consideration by the wildlife commissioners at their April 2016 meeting. The winner will be announced at the Commissioners' meeting in July.
